Fayette County will have 3.5 billion dollars invested by a Korean company to manufacture the batteries for the electric vehicles, creating 2200 new jobs for Ohio. **COMMUNICATIONS FROM CITIZENS:** Susan Lehman, 1308 Turner Rd., new owner of Nest 1896 at 204 W. Columbus Ave., here with concerns of new parking plans on W. Columbus Ave. Concerns include Anytime Fitness using most of parking causing limited parking. Most customers utilize Lot 6 across the street which will now become monthly parking. Questions where will vendors and customers park. Understands the reasoning of the city, but it will not help customer parking with no lot across the street. Here to share concern and ask Council to give more thought to this issue. Mayor Stahler responds that this should continue as a dialog in his office and shares he is a member of Anytime Fitness and has never had an issue with parking. Every business owner would like to have an unloading spot for vendors but it is not possible. There are 766 parking spots available for downtown.

Mr Dodds recognizes that changes will be difficult for citizens that are used to current parking and added that there now free spaces in the lot right around the corner of Nest 1896. Large signs are posted for free parking.

Mr. Lile asks about parking for vendors in the rear of the property. Mrs. Lehman replies that concrete stairs make it difficult for vendors to use the rear of the building.
