Asks for Council consideration on Ord. 23-71 for the parttime prosecutor to contract out \$40 an hour for two/three days a week. And also for Ord. 23-73 regarding the full-time prosecutor office, which is down by one prosecutor, causing strain on daily operations. Having not been able to fill the position due to our not being priced accordingly. Asking for an increase up to \$93,700.00 which is split 60/40 between the city and the county. Appreciates Council

consideration for these requests.

Auditor -Regarding Ord. 23-70, an amendment to Ord. 13-40 that created the parttime Account Clerk position,

> shared between the Auditor's Office, Tax Department and Mayors Office. In the last seven years this has been a fulltime job in the Auditors Office. The amendment will get the position in line with what the Account Clerk actually does. The new title would be Asst. Deputy Auditor, for the Auditors Office only. Concerning Ord. 23-83, Temporary Appropriations Ordinance, the exhibit has 6 pages vs. 2 pages from the previous year which is due to the recommendation and findings from the State Auditors Office during the

2022 audit. This will bring it in line with the Ohio Revised Code minimum level of control by Council.

Parks & Rec-Thanks the community, elected officials and future elected officials for the outpouring of support during

the levy campaign.

Economic Dev- Marysville had a referendum up for a 260 acre housing development approved by Council. Residents
