1320 – VACANT BUILDING ENFORCEMENT PROGRAM

Effective December 8, 2015 The City of Bellefontaine enacted a Vacant Building Registration Program.

Our records indicate that the property listed below is vacant and must be registered with the City of Bellefontaine:

PROPERTY ADDRESS:

Section 1320.01 – Purpose - Structures which are left vacant for extended periods of time have been shown to breed crime, pose public safety risks, and reduce property values and the economic viability of the community in which they are found. The purpose of this chapter is to establish a program for identifying and registering vacant buildings; to determine the responsibilities of owners of vacant buildings and structures; and to provide incentives for the rehabilitation and productive use of vacant buildings. Shifting the cost or burden of the existence of vacant structures from the general citizenry to the owners of the buildings is an intended result of this chapter.

As outlined in Section 1320.08, any person violating any provision of this ordinance shall be subject to the penalties listed in Section 1319.99 which are as follows:

Any violation or failure to comply with provisions contained in Chapter 13 of the Codified Ordinances of the City of Bellefontaine, including failure to comply with notices issued thereunder, will be subject to:

A misdemeanor of the fourth degree for the first offense, third degree misdemeanor for the second offense, and misdemeanor of the second degree for the third and subsequent offenses. Each day of violation or failure to comply shall constitute a separate offense.

We encourage you to take this matter seriously and have you structure registered as soon as possible to avoid any legal action taken against you.

Enclosed is a registration form that you will need to fill out and return to our office with the proper fees due.

If you have more than one property that is vacant, please list them in the extra spaces we have provided, so that we can update our system accordingly.
